

Mohr Animal Acres CSEgg Agreement

I appreciate locally raised, pesticide-free products and want to participate in Mohr Animal Acres' Community Supported Egg Program (CSEgg). I understand that Mohr Animal Acres will do its best to provide sustainably-produced eggs on the dates and at the times scheduled.

Eggs: Mohr Animal Acres' eggs are produced by hens that are free-range and they forage for most of their food. If necessary, their diet will be supplemented with a natural feed.

Pricing: The price of a package is \$37.00. This fee covers the cost of eggs, delivery to a central location in Wyoming, and a small administrative fee. Payment is due with the signed CSEgg Agreement.

Packages: On each pick-up date, I will receive one (1) box of up to one dozen (12) eggs for each package purchased. When the hens are producing as anticipated, each package will contain twelve (12) eggs. However, if weather conditions are extreme and egg production is affected, the available eggs will be evenly divided so that each package will receive an equal quantity of eggs. Adjustments will not be made on subsequent delivery dates. Packages are allotted on a first-come, first-served basis and will not be held without payment.

Pick-up: Eggs will be available for pick-up at 916 Springfield Pike, Wyoming, between 2 and 6 pm on the following dates:

December 8, 22,
January 5, 19,
February 2, 16,
March 2, 16, 30, and
April 13

If I cannot pick up my eggs within the specified time-frame, I can send a representative in my place. My representative simply needs to give my name at pickup or sign the pick-up form. Mohr Animal Acres reserves the right to donate any eggs not picked up by 7 pm to charity.

In the event that the pick-up location changes, I will be notified either by email or telephone at least 2 days in advance about the change.
